## VENDOR GUIDELINES

**Registration Fee:** The registration fee is **\$45.00** if remitted before May 1. Late fees may apply if remitted after May 1, 2018. Make registration check payable to **CFA, Inc.**, or use PayPal. The registration fee must accompany the enclosed registration form and is non-refundable. Reduced fee made possible through generosity of First Energy.

**Sales Tax:** Participating vendors are responsible for collecting and remitting Maryland (6%) sales tax. Names and addresses of participating vendors are required to be forwarded to the Comptroller of Maryland's office

**Display Spaces:** Spaces are available in two 40' x 40' tents. If desired, individual tents may be utilized and will be arranged in clusters around the main tents. All sites are flat and easily assessable. Display spaces will be assigned by festival sponsors. **All spaces will be 10'x10' in size.** Festival sponsors will attempt to accommodate advance requests for special space requirements.

**Security:** **Security in vendor area is arranged for Friday & Saturday nights.**

**Tables & Chairs:** NOT provided. Vendors must supply their own display tables and chairs.

**Electricity:** Electricity will be limited to vendors demonstrating their craft e.g. potter's wheel, upon request and availability.

**Camping:** For campsite inquiries, please contact Cunningham Falls State Park at 301-271-7574.

**Display Items:** **Only hand-made items may be displayed or offered for sale.** Art items with a nature-based and/or historic theme are preferred. **Mass-produced and commercially produced items are strictly prohibited.**

**Parking, Set-Up and Tear-Down:** Vendors will Check-in at the Furnace parking lot to receive their location. After acquiring site location, Vendors should proceed to unload and immediately park vehicles where directed, before setting up. Volunteers will assist with parking. Hand carts are strongly recommended. **Vendors may not leave the festival area before 5 p.m. on Saturday or Sunday.**

**Loss & Damage:** Participating vendors agree to hold the Friends of Cunningham Falls and Gambrill State Parks, Inc., Harriet Chapel, Rocko Meats, CFA, the Catoctin Furnace Historical Society, and the State of Maryland harmless for loss or damage of merchandise due to weather, theft, fire, negligence or any other reason. Vendors are responsible for securing their own insurance.
